# INFORMATION ABOUT THE VETERINARY TECHNOLOGY PROGRAM

## DESCRIPTION

The **Veterinary Technology program** is a sequence of courses designed to prepare students for careers in the field of veterinary technology. Learning opportunities develop academic and professional knowledge and skills required for job acquisition, retention, and advancement.

Program graduates are to be competent in the general areas of humanities or fine arts, social or behavioral sciences, and natural sciences or mathematics. In addition, the program emphasizes specialized training in animal health and care. Program graduates receive a **Veterinary Technology Associate of Applied Science Degree**, developed in accordance with the American Veterinary Medical Association (AVMA) accreditation guidelines, and are eligible to sit for the National Board examination to become qualified as Registered Veterinary Technicians. The program emphasizes specialized training in animal health and care developed in accordance with the AVMA accreditation.

## LICENSURE/CERTIFICATION

A graduate of the program, accredited by the American Veterinary Medical Association (AVMA) Committee on Veterinary Technician Education and Activities (CVTEA), must apply with the State of Georgia Secretary of State and have a passing score on the Veterinary Technician National Examination (VTNE) to become registered in the State of Georgia. Out-of-state students should check with their respective state licensure board to determine requirements.

# STUDENT PREGNANCY RISK MANAGEMENT POLICY

## POLICY

- » Veterinary Technology students are potentially exposed to materials or incidents that may result in human injury. Some of these exposures could potentially affect pregnant women or their unborn child. Possible exposures may include infectious agents, drugs, chemicals, inhaled anesthetics, radiation, and other agents. Ogeechee Technical College will strive to provide equal opportunity for all students who are academically qualified and to ensure that all students are accommodated. It is the responsibility of the pregnant student to initiate requests for accommodation and to help arrange these accommodations.

## PROCEDURE

- » Students who are pregnant or who are actively trying to become pregnant should:
  - » Consult with their individual instructors regarding types of hazards to which the student may be exposed. Examples of possible reproductive hazards are listed in Appendix A.
  - » Contact their treating physician immediately to obtain recommendations for a plan to minimize exposure to hazards with the possibility of reproductive effects to which they may be exposed.
- » If accommodations, work restrictions, or class schedule changes are recommended, contact Brandi Helton, Dean of Students, Office 198, Joseph E. Kennedy Building, 912.912.486.7607; bhelton@ogeecheetech.edu as early as possible so steps may be taken to assist the student in conforming to a plan developed by her physicians. The student will be asked to provide a copy of the specific restrictions or accommodations requested by her physician.

## OPTIONS FOR STUDENTS

- » Continue as a student with no schedule or assignment changes if no significant reproductive hazardous exposures are anticipated.
- » Continue as a student with some schedule and assignment changes to minimize certain potential exposures. The flexibility of scheduled changes under this option is dependent on the scheduled assignments and the willingness of classmates to exchange assignments with the affected student.
- » The student may request a leave of absence for a time period deemed necessary by her physician. The student would be responsible for making up assignments or courses missed during the leave of absence.
- » The student may withdraw from the program. The student may then request readmission into the next class. In years 1-3 this could mean a student would need to be on leave for one full year as the classes are lock stepped.

## RIGHTS AND RESPONSIBILITIES

- » It is recognized that a pregnant woman or women actively seeking to become pregnant have rights and the responsibility for decisions concerning the pregnancy. No one acting on behalf of Ogeechee Technical College may discriminate against a student on the basis of pregnancy. The woman should expect due consideration from everyone associated with her pregnancy whatever her decision may be.

At the same time, the pregnant student is expected to complete each and every requirement of the veterinary curriculum by a schedule or plan that can be reasonably implemented and under which risks are deemed acceptable by her and her physician.

*Note: Appendix A includes some examples of possible hazards to a pregnant woman but is not an all-inclusive list.*

# APPENDIX A: POSSIBLE HAZARDS FOR PREGNANT WOMEN

Some examples of agents that may pose a possible reproductive hazard in pregnant students are listed below. This Appendix includes possible examples of reproductive hazards but is not an all-inclusive list. Further information may be obtained from some of the sources listed below. However, the actual hazard or risk to the pregnant woman depends on the type of exposure, route of exposure, length of exposure, use of personal protective equipment, underlying medical conditions, and other factors.
